You may be a Class Member in a class action against Pluris Wedgefield, LLC, Pluris Holdings, LLC, and Pluris Wedgefield, Inc. ("Pluris"). This Notice is only a summary. Pluris Wedgefield, LLC, et al., No. 2020-CA-004390 (Fla. 9th Cir. Ct.).

Why am I getting this Notice? You have been identified as a potential "Settlement Class Member" from Pluris's Customer List because you were a residential customer who paid for water distributed by Pluris from April 12, 2016 through December 29, 2022.

Settlement Terms. Pluris will pay a total Settlement Amount of $\$ 3.3$ million, which will be divided between each eligible Class Member on a pro rata basis after expenses, costs and Class Counsels' fees are taken out. The Court will decide what the reasonable attorneys' fees amount is. Payments to Class Members will be based upon the total amounts paid by each Class Member for his or her water received from Pluris during the Class Period. In addition, Defendants have agreed to additional sampling and testing.

How do I receive payment? Membership in the Class will be determined by reviewing the Defendants' billing records. No action is required on your part to participate in the Settlement, and the Settlement Administrator will distribute payments after the Court grants final approval to the Settlement.

What are my options? You can do nothing and receive payment if the Court approves the Settlement and the Settlement Administrator determines you are eligible, exclude yourself ("opt out"), or object to the Settlement. The deadline to opt out or object is March 6, 2023. If you do not opt out, and the Court approves the Settlement, you will release your claims against Pluris. The Court will hold a hearing on April 3, 2023 to decide whether to approve the Settlement. You may attend.
